

End-User License Agreement (EULA) of Jervinho

This End-User License Agreement ("EULA") is a legal agreement between you and listener[®]

This EULA agreement governs your acquisition and use of our Jervinho Typeface ("font") directly from listener[®] or indirectly through a listener[®] authorized reseller or distributor (a "Reseller").

Please read this EULA agreement carefully before completing the installation process and using the Jervinho software. It provides a license to use the Jervinho software and contains warranty information and liability disclaimers.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not install or use the Software, and you must not accept this EULA agreement.

This EULA agreement shall apply only to the fonts supplied by listener[®] herewith regardless of whether other fonts is referred to or described herein. The terms also apply to any listener[®] updates, supplements, Internet-based services, and support services for the fonts, unless other terms accompany those items on delivery. If so, those terms apply.

License Grant

listener[®] hereby grants you a personal, non-transferable, non-exclusive licence to use the Jervinho font on your devices in accordance with the terms of this EULA agreement.

You are permitted to load the Jervinho software (for example a PC, laptop, mobile or tablet) under your control. You are responsible for ensuring your device meets the minimum requirements of the Jervinho software.

You are not permitted to:

Edit, alter, modify, adapt, translate or otherwise change the whole or any part of the font nor permit the whole or any part of the font to be combined with or become incorporated in any other software, nor decompile, disassemble or reverse engineer the font or attempt to do any such things

Reproduce, copy, distribute, resell or otherwise use the font for any commercial purpose

Allow any third party to use the font on behalf of or for the benefit of any third party

Use the Software in any way which breaches any applicable local, national or international law

use the Software for any purpose that listener[®] considers is a breach of this EULA agreement

Intellectual Property and Ownership

listener[®] shall at all times retain ownership of the font as originally downloaded by you and all subsequent downloads of the font by you. The Software (and the copyright, and other intellectual property rights of whatever nature in the font, including any modifications made thereto) are and shall remain the property of listener[®].

listener[®] reserves the right to grant licences to use the font to third parties.

Termination

This EULA agreement is effective from the date you first use the font and shall continue until terminated. You may terminate it at any time upon written notice to listener[®].

It will also terminate immediately if you fail to comply with any term of this EULA agreement. Upon such termination, the licenses granted by this EULA agreement will immediately terminate and you agree to stop all access and use of the font. The provisions that by their nature continue and survive will survive any termination of this EULA agreement.

Governing Law

This EULA agreement, and any dispute arising out of or in connection with this EULA agreement, shall be governed by and construed in accordance with the laws of ma.
